## **Cancellation Policy:**

**House Sitting & Train Boarding**—2 weeks prior

**Training & Exercise Groups & other services**—24 hours prior to the service

Buddy charges 100% of the service price if cancellation occurs outside the above timelines.

## **Injury and Hold Harmless Agreement**
